1. Call to Order, Roll Call

The meeting was called to order at 3:50 p.m. by President Williams who chaired the meeting. Those in attendance were:

President Williams requested that the agenda order be changed. Director Bettencourt moved to consider Item #7 first, seconded by Director Abel, passed 7/0/0.

7. Consider Options Regarding Award of Construction Contract for SCC Upper Reach Reliability Project

Ms. Rees reported that the COMB Board approved solicitation of construction bids for the 2nd Pipeline Project on July 27, 2009. Bids were received and opened on September 10, 2009 and the apparent low bidder was Don Kelley, Construction. The bid document states that within a period of 90 calendar days after the opening of bids, the Owner will accept or reject the bids. The 90 day period ends December 9, 2009. Due to the delays in getting the bond and other funding approved for the 2nd Pipeline Project, Ms Rees said there was no way to award the contract by December 9, 2009. Doug Brown and Bill Hair have advised that COMB must have the funds in the bank before awarding the construction contract.

The Board was asked to consider two options.

- 1) Reject all bids and rebid the project after all funding approvals have been attained from each member unit and COMB.
- 2) Let the award date pass and do nothing at this time.

Glen Hille of AECOM, the design engineer, believes that the re-bids could be as much as \$1 million higher than the first bids. He reported that the average of the bids received was \$9.3 million with a range between about \$11 million and \$8 million. Mr. Hille also reported that Kelly Construction said they would honor their labor costs, equipment costs, and their main in house costs for an extra 30 days while funding is put in place. But that there may be suppliers that have had increases in material costs.

Bill Hair stated that there is nothing in the bid specs that would prevent COMB from doing nothing at this time. His recommendation, therefore, was to do nothing at this time to protect the low bid.

After Board discussion the decision on this item was deferred until later in the meeting.

Item #6 was considered next

- 6. COMB 2009 Revenue Bond and Related Legal Documents and Agreements for the SCC Upper Reach Reliability Project (2nd Pipeline Project)
 - a. CVWD's Decision Not to Participate in Funding the 2nd Pipeline Project
 The CVWD Board decided not to participate in the funding of the 2nd Pipeline
 Project. Charles Hamilton reported that the District's lack of money caused the
 CVWD Board to change its mind about funding its share of the project. He said
 their reserves were not sufficient to pay for the COMB project plus the District's
 own capital improvement needs. In addition, CVWD believes it would receive
 marginal benefit from this project.

Director Bettencourt reported that ID#1 will approve the project and the COMB bond, but that he was not authorized to vote in favor of the COMB resolution that approves the financial documents and ID#1's Indemnification Agreement until the ID#1 Board first approves them. That approval is scheduled for ID#1's December 15, 2009 meeting. He said that COMB did not need to approve them first.

b. MWD's Conditional Approval of Funding Increase for the 2nd Pipeline Project Without CVWD Participation

Director Abel reported that on October 12, 2009 MWD approved an 11.5% contribution for the full list of priority projects. When the CVWD Board decided not to participate in funding any portion of the 2nd Pipeline Project, it also voted to consider funding each of the other priority projects one-by-one. The other Member Units followed suit, so the 2009 Project was reduced to the 2nd Pipeline Project only. On November 17, 2009, the MWD Board took action to pay its share as well as an 11.5% share of CVWD's amount subject to CVWD agreeing not to use the 2nd pipeline when the 1st pipeline was not being used. That was not acceptable to CVWD. MWD will be considering a new contribution agreement with the change in projects and funding participants at its November 25, 2009 meeting.

c. GWD Decision Regarding Funding Increase for the 2nd Pipeline Project Without CVWD Participation

Director Hanson reported that GWD has been supportive of all the projects all along and that they continue with that support for the 2nd Pipeline Project. The GWD Board has entertained the suggestion to use a judge to evaluate the cost sharing percentages among the Member Units. Fran Farina, GWD General Counsel stated that the GWD Board will be re-voting on their participation at its December meeting.

d. City of Santa Barbara's Decision Regarding Funding Increase for the 2nd Pipeline Project Without CVWD

Director Williams reported that the City of Santa Barbara continues to want to move forward with this project. Director Williams would like to see some evidence that the Mission Creek project is also moving forward as well as the 2nd Pipeline Project. He also stressed the need to have a penalty mechanism in place for over use of the conduit in peak demand time.

Rebecca Bjork explained the role that Gibraltar Reservoir plays in assisting the other Member Units in meeting their peak demands. The limitations in meeting peak demands currently are not capacity issues at Cater; rather it is keeping up the water flow into Lauro Reservoir. This limitation is not caused by the City's demand. It is due to the inability to get enough water between the South Portal and the Corona del Mar Water Treatment Plant. Given the decreasing capacity at Gibraltar, the City may not be able to continue to supplement peak demand with water from Gibraltar into Lauro. The City is not able to get their full Cachuma entitlement as things are currently.

In order to be fully supportive of the project Director Williams stated that he needs some assurances that the Mission Creek project would be completed, but stated that he was very committed to the project.

e. Set Deadline by shich All Member unit Board Must Reach Final Decision on Funding for 2nd Pipeline Project

Ms. Rees requested that each of the Member Unit managers confirm with her each their agency's final decision on participation in the 2nd Pipeline Project by December 9, 2009 in order for all the legal documents to be completed.

The schedule for final approval for each Member Unit:

MWD is meeting November 25th.

GWD is meeting December 8th.

CVWD is meeting December 9th.

ID#1 will schedule a special meeting if the indemnification agreement is completed. City will add the contribution agreement on their consent agenda December 8th.

Ms. Rees suggested scheduling a Special COMB Board meeting on December 11, 2009. All Directors were able to meet on December 11th at 9:30 a.m. At this

meeting COMB will approve the Official Statement, the Indenture of Trust, the Joint Participation Agreements, the MWD Contribution Agreement, and all of the Indemnification Agreements. Each of the Member Units must make their final approvals prior to December 11th.

8. Consider Approval of COMB Change Work Order Policy

Director Abel moved to approve the Change Order Board Policy, Counsel Bill Hair had a correction to the first section, the 1.3 (h) (iv) should be 1.3 (h) iv), Director Abel adjusted her motion to the slightly revised version, seconded by Director Williams. During discussion Director Abel called the question, passed 4/1/2, Director Bettencourt voted no, Director Hanson abstained. The motion to approve the Change Order Policy passed 6/1/0, Director Bettencourt voted no.

9. Proposition 50 and Proposition 84 Activities

Ms. Rees reported on the County of Santa Barbara's difficulty in continuing the Prop 84 process. The total amount available for funding the entire Central Coast Region is \$52 million dollars. Only 1/9 of that amount can be released per region for Phase 1, which amounts to \$5.7 million for the Santa Barbara County Region. The participating partners are discussing if it is worth submitting a grant application at this time for Phase 1, or wait to submit grant applications for Phases 2 and 3.

10. Directors' Request for Agenda Items for the Next Meeting

Director Hanson requested that a report from the Quagga Mussel Ad Hoc Committee be added to the agenda for December 21, 2009.

Director Bettencourt requested that his previous request regarding the opinion letter from COMB's legal explaining why the Biological Opinion activities are not water rights issues be on the December 21, 2009 agenda.

Director Hanson introduced Bill Rosen, the newly elected President of the Board for the Goleta Water District and their new General Manager, John McInnes.

Ms. Rees reported that today the Board would be considering approval of the revenue bond and related legal documents and agreements for the SCC Upper Reach Reliability Project. She also noted that at the table was the latest revised MWD Indemnification Agreement and a new Indemnification Agreement for CVWD. Doug Brown, bond counsel was available via phone for any questions and also gave an overview of the process for today's meeting. The above list (a-i) the agreements and legal documents included in the approval of Resolution 497. This would be the last action taken by the COMB Board prior to selling the bonds.

Fran Farnia, GWD counsel pointed out a correction that should be made in the COMB Indenture of Trust, Section 3.06. The language that should be removed refers to, "COMB may substitute other improvements for those listed as components of the Project". There are no substitute projects; the only project is the 2nd Pipeline Project.

Director Bettencourt announced that he was not authorized by his Board to vote on any action today without the Indemnification Agreement in place for ID#1. His Board will be meeting Tuesday, December 15th to approve their Indemnification Agreement and also approve the COMB bond.

Dick Shaikewitz, MWD Board President expressed concern over the addition of the CVWD Indemnification Agreement at the last minute, stating that his Board has not had a chance to study the agreement and could not recommend approval of it today.

There was discussion as to which agency needed to approve the ID#1 Indemnification Agreement and COMB bond issue first. Ms. Rees, Ms. Farina, and Mr. Wullbrandt were under the impression that Gary Kvistad and Chris Dahlstrom indicated COMB needed to approve ID#1's agreement before it was approved by the ID#1 Board. However, Director Bettencourt and Mr. Kvistad stated that COMB did not need to approve the agreement beforehand. ID#1 will consider approval at its December 15th meeting, and Director Bettencourt said he could then vote approval of the COMB legal documents and indemnification agreements at the December 21st COMB Board meeting.

Each COMB Director reported on the status of the approval process for their individual Boards/Council:

- Director Hanson reported that GWD Board has voted and that she is ready for COMB approval
- Director Lieberknecht reported that CVWD has voted and that he is ready for COMB approval
- Director Bettencourt is ready to approve ID#1's Indemnification Agreement and receive authorization from the ID#1 Board to vote for COMB approval
- Director Abel reported that MWD has voted and that she is ready for COMB approval
- Director Williams reported that the City has voted and that he is ready for COMB approval

For the record, Director Hanson read from GWD's Resolution No. 2009 – 18, Section 4. "ID No. 1 Indemnification Agreement. The form of Cachuma Operation and Maintenance Board 2009 Revenue Bond Indemnification Agreement by and between COMB, the District, City of Santa Barbara and Santa Ynez River Water Conservation District, Improvement District No. 1 (the "ID No. 1 Indemnification Agreement") presented to this meeting and on file with the Secretary of the Board of Directors is hereby approved. The President or Vice President and the Secretary of the Board of Directors are each hereby authorized and directed to execute, acknowledge and deliver said ID No. 1 Indemnification Agreement in substantially said form, with such changes therein as the General Counsel of the District or Bond Counsel may require or approve, such approval to be conclusively evidenced by the execution and delivery thereof".

Director Hanson moved to table Item #3 to the December 21, 2009 regular COMB Board meeting, seconded by Director Bettencourt, passed 7/0/0.

4. Schedule Sale of Bonds and Rebid of Construction Contract for SCC Upper Reach Reliability Project (2nd Pipeline Project)

Ms. Rees reported that the COMB Board voted to reject all bids and rebid the 2nd. Pipeline Project at its November 23, 2009 regular meeting. Staff requested that the Board set a schedule for rebidding the 2nd Pipeline Project. The Directors requested that AECOM start the rebid process as soon as possible.

Ms. recommended waiting to sell the bonds until after the new bids have been received in order to properly cost the bond issue. Director Hanson asked if this would still allow the project to begin early in 2010. Ms. Rees reported that the next window of opportunity to begin the project would be early summer of 2010.

5. There being no further business, the COMB meeting was adjourned at 10:30 a.m.

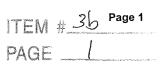

RE: Ad Hoc Committee Appointment to COMB Operating Committee

RECOMMENDATION:

That the President of the Board appoint two COMB Directors to an Ad Hoc Committee to the COMB Operating Committee.

DISCUSSION:

At the November 4, 2009 COMB Operating Committee meeting, a discussion on the roles and responsibilities of the Operating Committee resulted in the Committee requesting that these be clarified by the COMB Board. It was suggested that an item be placed on the January 25, 2010 Board meeting agenda allowing sufficient time for a full Board discussion. To facilitate that discussion, the Operating Committee and staff requests that the President appoint an Ad Hoc Committee to attend the January 13, 2010 Operating Committee meeting to discuss and refine the Committee's functions and responsibilities, and determine how the Operating Committee might be better integrated into the agency.

Attached are the staff memos from the January 26 and February 23, 2009 Board meetings regarding the formation of the Operating Committee.

Below is also a brief summary of the Operating Committee's suggested responsibilities for discussion.

- Should be patterned very closely after CCWA; the CCWA Board receives input from the Ops Com on every level
- Should be a branch of the decision making on all levels
- Should evaluate contracts, agreements, engineering designs, etc. and make recommendations directly to the Board
- Should develop recommendations to the Board regarding policy matters and financial decisions
- Should be a resource to COMB GM with assistance provided by the other Cachuma GMs
- Formed to have issues addressed at the Ops Committee level first to avoid discussions among the GMs at the Board meetings. Should vet items on the COMB agenda prior to taking them to the Board
- CIP Coordination Committee needs to be given a higher level of responsibility to handle technical planning issues among the Member Units at the engineering level. Those issues would then be brought the Ops Committee for review before going to the Board
- Operational and budgetary issues are the main focus not water supply

- Other than routine items, everything should be brought to the Ops Committee first
- Recommendations should be developed by the Ops Committee for input to the COMB GM; COMB GM will make recommendations to the Board. Does not prohibit GM from making the recommendation he/she thinks is best

Operations Report – November 2009

The average flow from Lake Cachuma into the Tecolote Tunnel for November was 84 acre-feet per day. Lake elevation was 732.28 feet at the beginning of the month and 730.95 feet at the end. 98 acre-feet of State Water Project water was wheeled through Cachuma Project facilities and delivered to South Coast Member Units during the month.

Conditions at Ortega Reservoir have remained consistent over the month, with weekly monitoring of drain flow, piezometer elevations and site conditions.

Other activities conducted this month include:

- Jesusita Fire recovery efforts at Lauro Reservoir during November continued with tree removal and erosion control measures around at Lauro Reservoir. A complete progress report for Jesusita Fire recovery efforts will be included in the board packet for the January board meeting.
- The COMB Field Crew received training by the California Department of Forestry and Fire Protection for procedures to supervise and interact with youth conservation camp wards.
- COMB Staff provided a demonstration for the Santa Barbara County Parks
 Department of the North Portal Intake Tower screen cleaning to inspect for
 Quagga Mussels.
- The process of converting hard copy encroachment files to electronic format began in November with a large-scale scanning effort.
- Meter calibration on the Lower Reach of the SCC took place, with the removal and calibration of the Propeller Flow Meter at Asegra Rd.
- Progress continued on the 2nd Pipeline and Mission Creek projects. A complete status of the projects is included in the board packet for the December COMB board meeting.

Routine operation and maintenance activities conducted during the month included:

- Sampled water at North Portal Intake Tower
- Monitored conduit right-of-way and responded to Dig Alert reports
- Read piezometers and underdrains at Glen Anne, Lauro and Ortega Dams
- Read meters, conducted monthly dam inspections, and flushed venturi meters

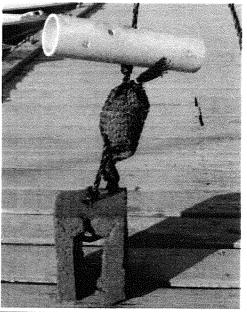

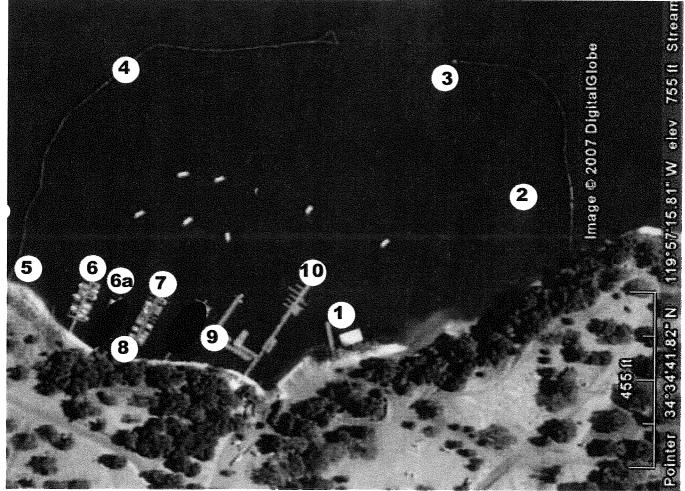

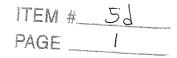
Attached is an email from Juan Beltranena, the Project Manager for Santa Barbara County Parks. He has requested using projects COMB or CCRB has carried out and paid for at Lake Cachuma to list as a match for a federal grant application for infrastructure improvement projects at Lake Cachuma.

The Bureau of Reclamation recommended that he contact COMB to request permission to use work associated with the installation of the gabion barrier wall around the Water Treatment Plant, the lake elevation survey, or any other work completed by COMB or CCRB at Lake Cachuma after 2004, as matching funds.

Projects that might be used as a match are:

- 1) Modifications to Bradbury Dam for installation of the flashboards and radial gate painting completed November 2004 \$2,584,775
- 2) Lake elevation survey completed January 2005 \$12,976
- 3) Gabion basket barrier wall completed April 2005 \$41,757 Tierra Construction \$41,757.24
- 4) Oak Tree Mitigation Program ongoing 2005-2009 \$443,523

Staff does not foresee COMB's use of these matching funds for other projects. Recognizing the financial difficulties the County is facing, they do not have the resources to provide matching funds for the grant application. In the spirit of cooperation and to support the County's efforts to improve the facilities at Lake Cachuma that will also protect the water quality of the lake, staff and the majority of the Operating Committee agreed it would be acceptable for County Parks to use the projects listed above if they wish to do so.



One issue that needs to be addressed is the County's consistent misperception that the surcharge requirement in the Cachuma Biological Opinion for endangered steelhead is the primary reason the critical park facilities need to be replaced or moved. This is incorrect. Even with a full 3 foot surcharge, there is no impact to the critical park facilities, as shown by the 2005 lake elevation survey conducted during a full 3 foot surcharge. The County's original elevations were in error. All of the park facilities are more than 50 years old and need to be replaced regardless of surcharging the reservoir. The Operating Committee requested that I send a letter to County Parks explaining why the issues they have raised in the past are not valid or accurate. In the interim, an email was sent to Mr. Beltranena with a brief explanation.

Hi Juan -

Thanks for your patience. I decided that I needed to discuss your request with the COMB Operating Committee (Cachuma GMs), which I did on Dec 2nd. Except for Chris Dahlstrom (ID#1), they were in general agreement that you could use any or all of the projects listed below as a match for the federal grant for which you are applying. As you know I support that as well, and it does not appear that COMB or CCRB could use these projects as a grant match for any of the work we are involved with. So, in the interest of cooperation, the majority of the managers were in agreement that you could use them in your grant application.

There were some comments and questions, however. First of all, the County has consistently maintained that the surcharging Lake Cachuma is the main reason County Parks needs to upgrade and/or move its critical facilities, such as the Water Treatment Plant, and Sewage Lift Stations, and Boat Launch Ramp. This is simply not true, and should not be stated as such in emails, grant applications or in the Park Department's reports to the Board of Supervisors. It has long been known that the virtually all of the infrastructure facilities are in need of upgrading or replacing, regardless if the reservoir is surcharged or not. This was clearly stated by Reclamation in its draft EIS for Cachuma Park contract renewal.

The height of the boat launch ramp was increased before Reclamation fully surcharged the lake, and CCRB and ID 1 agreed to limit the surcharge elevation per an MOU with the County until the new boat launch ramp was built. There was no impact to the boating public as a result. The purpose of Stetson's 2005 lake elevation survey was to see exactly what was affected by surcharging the reservoir a full three feet. It was shown that there was no impact to the WTP or the sewage lift stations, but we acknowledged that there could be some impact to the WTP from wave run-up. Consequently, we built the gabion barrier wall around it, and there has been no impact to the plant from surcharging the reservoir or during spill events. With regard to the lift stations, only the setback was affected by surcharging the reservoir – not the lift stations. There may be some impact to non-critical facilities such as parking lots, walkways, or picnic areas, but these were never an issue for consideration when the County negotiated the MOUs for limiting the surcharge – only the critical facilities were considered, and surcharging has no effect on those facilities. Therefore, we request that you refrain from making statements that continue to be misleading.

I will be informing the COMB Board at their meeting on Dec 21st that the Operating Committee and I are recommending that County Parks use these projects as matching funds for a federal grant application. You mentioned in your email that several park infrastructure facilities need to be relocated or upgraded. Would you please let me know for which facilities you are submitting a grant application, to which federal agency, and the amount of the grant application, so that I can include that information in my staff report.

Lastly, what do you need from us? I have provided the completion dates and construction amounts below. Do you need copies of the construction contracts as well? The contracts for the 2005 Stetson Survey and construction of the gabion barrier wall were run though ID#1, so Chris has those contracts – I don't. Although CCRB reimbursed ID#1 for 90% of the costs, Chris may be reluctant to release them because he was not in favor of assisting with this. He did agreed not to go against the OpsCom recommendation, however. So hopefully you don't need them, but please let me know.

I'll confirm this approval after the COMB Board meeting on Dec 21. Here's the list of projects we have completed at Lake Cachuma since 2004. We have no plans for additional work within the next two years.

Thank you for retuning my call on the subject of using some of the work COMB has executed at Cachuma Lake to serve as "match" in the Parks Department's quest to obtain Federal funding for infrastructure improvement projects at Cachuma Lake.

As you know, because of the National Marine Fisheries Service's determination that efforts should be made to restore anadromous fish populations in the Santa Ynez river and the consequent desire to surcharge the lake, several park infrastructure facilities need to be relocated or upgraded to continue to safely serve the park. To that end, the County has secured a number of grants from the federal government to execute this work. These grants however, require that Parks provide matching funds for the grants in an amount that is beyond the County's current fiscal abilities.

To that end, we would like to request that Parks be authorized to use the work associated with the recent work for the installation of "rock and gabion protection" measures COMB implemented to protect the intake of the water treatment plant, as well as any other qualifying work your agency has implemented, as part of the said required match funds for our federal grants.

For these match expenditures to qualify as "match", they need to be related to lake Cachuma, have been executed from 2004 forward, and not have already been used as "match" for other grant funds. Additionally, any work contemplated in the near future (up to 2012) might also qualify as "match".

If the "rock and gabion measures" to protect the intake facility meet these requirements, and your agency is willing to allow Parks to use these expenditures as a match for our grants, please let me know the amount spent by your agency on this project. In the same vein, if there are other projects you or your staff think would meet these conditions, please let us know so we can consider them for inclusion as well.

As you might imagine, a multipurpose project of this complexity requires the effort and support of Federal, State and Local Governments to achieve success. Thus, we would be grateful for any assistance COMB can provide the Parks Department in this matter.

Attached is the Prop 50 Agreement between the State Water Resources Control Board (SWRCB) and Santa Barbara County. There are a number of factors that are relevant to the reliability and availability of the Prop 50 funds. Before describing those. I will say that my personal opinion, from working with SWRCB representatives and managing the grant is that the funding is secure and will eventually materialize in full.

However, there are some things that affect the dependability and timing of funding. As you alluded to, funding was suspended to all grants in December of 2008 due to the State budget crisis. Funding for these grants comes from State bonds and therefore is subject to the strength and sale of those bonds. In the case of the suspension by the State, funding was reinstated by June with all invoices submitted to that time paid in full. Unfortunately, State representatives don't seem to have reliable predictions regarding the financial health of the bonds but all has moved smoothly since the original suspension.

As you may know, the SWRCB has recently suspended reimbursement to the Santa Barbara Prop 50 region due to an invoicing irregularity in which representatives for the Casmalia Community Services District received reimbursement for identical invoices from two different grants. The County Auditor is currently working with SWRCB representatives to establish a procedure by which such irregularities will be identified and prevented. The SWRCB has agreed to reinstate reimbursement for the grant once they are comfortable with the County's procedures. In the mean time, the State has continued to collect and process invoices from the Region's projects and State representatives are visiting next week to tour projects that are either underway or completed.

The attached contract will soon be revised. With 14 projects being funded, there have been inevitable modifications to project scopes and time lines. We will soon incorporate those changes into a modified contract. These changes will also necessitate modification of the grant sub-agreements between the County and each project proponent whose project will change substantially. If, for some reason, a project becomes infeasible the SWRCB will leave it to our Region to reallocate the funds designated for that project. However, the State has made it clear that they consider each proponent to be contractually obligated to complete their projects in accordance with the grant agreement.

DWR Announces Final Recommendations for the Region Acceptance Process

The Director of the Department of Water Resources (DWR) has approved the Integrated Regional Water Management (IRWM) Program Region Acceptance Process (RAP) final recommendations. DWR received 46 RAP proposals. DWR approved 36 regions and conditionally approved 10 regions.

Draft RAP Recommendations were released on September 1, 2009. Three public workshops were held on the draft recommendations (September 8, 2009, Sacramento, September 9, 2009, Los Angeles, and September 10, 2009, Fresno) to solicit public input. Written public comments were accepted until September 22, 2009. DWR received a total of 57 comment letters as well as oral comments during the three workshops. Region Acceptance Process Summary

General Description of Region

The Santa Barbara County Integrated Regional Water Management (IRWM) Region is located along the Pacific Ocean in the Central Coast Funding Area between the San Francisco Bay and the greater Los Angeles metropolitan areas. This Region's boundary is contiguous with the Santa Barbara County lines.

The Santa Barbara County Regional Water Management Group (RWMG) is made up of numerous regional agencies including, Santa Barbara County, cities within the County, water districts, sanitary districts, community services districts, and joint powers agencies. Currently, RWMG membership is open to governmental organizations, stakeholders, and any concerned groups that wish to participate; however, these entities do not have any voting rights. The Santa Barbara RWMG is developing a new Memorandum of Understanding (MOU) that would update the governance structure for the Santa Barbara IRWM Region. Under the new MOU, a Steering Committee would be created from a core group of members that are currently part of the Cooperating Partners. Any signatory of the new MOU may participate in the Steering Committee. Voting would be by a simple majority of all members participating in a Steering Committee meeting, and by consensus whenever possible. The tentative schedule for approval of the MOU is January 2010.

The Santa Barbara RWMG has shown that they actively pursue outreach and coordination activities. For example, the RWMG keeps in contact with San Luis Obispo and Watersheds Coalition of Ventura County IRWM Regions to address shared water quality and water supply issues in the Santa Maria and Rincon Creek Watersheds, respectively. The RWMG also participates in the Central Coast Funding Area regional meetings and has assisted Disadvantaged Communities by providing a portion of the administrative costs for Casmalia and Cuyama communities to participate in the IRWM planning process.

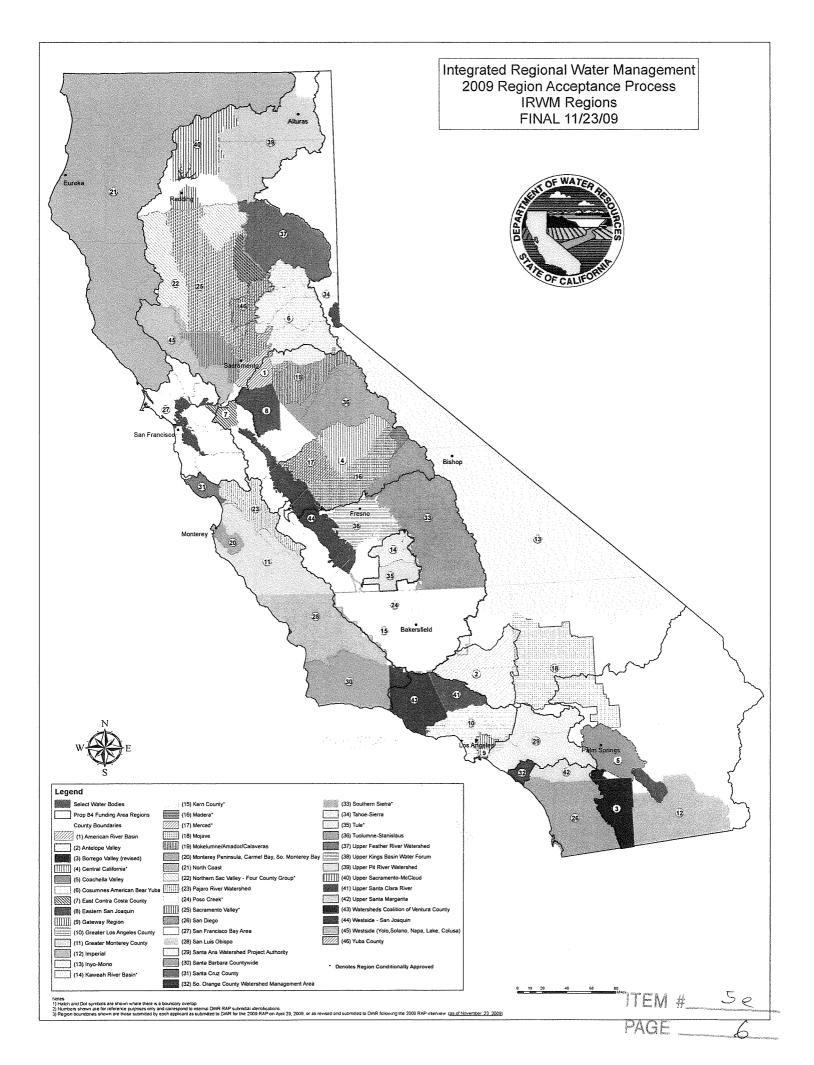

Dear Mr. Hamilton:

This is in reply to your November 30, 2009 letter regarding questions about the 2nd Pipeline Project and other COMB capital improvement projects, and other COMB issues. I have copied your questions and answered them below.

Schedule

Will the Second Barrel Project schedule allow for the draining and cleaning of the Carpinteria Reservoir by the end of March, given the restricted operations capacity of the Ortega Reservoir?

Carpinteria Reservoir cleaning will be scheduled for February or March 2010. We currently have a vacancy on the COMB operations staff and two of our crew members are on medical restricted duty. In addition one of the operations staff will be on vacation for most of January. Consequently, this is the earliest we will be able to clean the reservoir. You have provided assistance from the CVWD operations staff in past years, and because of our staffing limitations, I would like to request assistance from the CVWD operations staff again this year.

Has COMB obtained the necessary Add/Alter permit from the Bureau of Reclamation to allow the Project to proceed or has the Bureau given its permission for the Project to go forward without the Add/Alter permit in place?

An MP 620 Construction Permit from Reclamation is required. A permit application has been submitted and a construction permit is expected to be issued by Reclamation to COMB by March 2010.

Has COMB received and responded to comments from the CA Department of Public Health as to the plans and specifications for the Project? If so, would you please forward them to me?

Because only raw water will flow through the 2nd Pipeline, there was no specific need to provide the plans and specs to the Department of Public Health for review. We did submit the Notice of Preparation for the Draft EIR and the Notice of Completion for the Final EIR to the State Clearinghouse for circulation to appropriate state agencies, and did not receive any comments from the Department of Public Health.

Existing Conduit Structure

What portions of the existing Conduit structure are in such dire need of repair and/or replacement such that Glen Hille of AECOM predicts failure with the next five years (Goleta Water Board meeting 11/10/09)? What documentation exists beyond the 2003 Reliability Alternatives Study to support such a prediction?

The south portal concrete transition structure that connects the Tecolote Tunnel to the SCC is at risk due to extensive hydrogen sulfide corrosion, and at risk due to unstable soil conditions on the slopes in the immediate area.

Approximately 30% of the section of the SCC is structurally overstressed. If designed by current engineering standards, the SCC would be designed with substantially more "steel in the shell".

The design and construction of the nozzles/outlets for blow offs, air vents, and laterals were not constructed with a high quality lining. Consequently, internal erosion is apparent and extensive.

The existing SCC alignment crosses or parallels numerous landslides in Glen Anne Canyon. Due to the recent fires and wet season forecasts, landslide concerns are greatly elevated.

Does COMB have a plan to inspect, analyze, repair and/or replace portions of the existing Conduit structure other than what is called for as part of the Second Barrel Project? If not, why not? How would such work be funded so as not to increase COMB's Budget and add upward pressure on COMB member agency water rates?

To refresh your memory, COMB developed a long-term Capital Improvement Program at several years ago based on needed rehabilitation, repair, and improvements to the South Coast Conduit (SCC) facilities based on reliability studies completed by AECOM (formerly Boyle Engineering) for two reaches of the SCC. From those analyses, seven capital improvement projects were identified as priority projects with an estimated cost of \$26 million. This project list was thoroughly discussed with the Board's Capital Improvement Committee, approved by

the COMB Board, and presented to all the Member Unit Boards either by the COMB Directors, COMB staff, or both - in the case of CVWD, several times.

Seven priority projects (the 2nd Pipeline Project was only one of them) were proposed as an initial suite of priority projects to be funded through a COMB bond issue with the debt repayment built into the annual COMB budget in lieu of budgeting for about \$1.1 million of capital improvement work each year. If this had occurred, these projects could have been funded with bond money, and the COMB budget for that line item would have remained essentially flat for at least 5 years while the priority projects were being completed. After that time, if the COMB Board approved, additional project work would increase the budget unless other funds were made available for that purpose, such as money currently allocated for repayment of the capital cost of the Cachuma Project, which will be paid in 2015. Collectively that payment is at least \$1 million per year, a portion of which could be used to continue funding COMB's Capital Improvement Program, if the Member Units chose to do so. Or the COMB Board could decide to do only minimal capital improvement work in the future, thereby keeping the COMB budget at about the same level it has been for several years.

However, the CVWD Board decided not to approve its participation in the bond issue for the initial suite of projects, not to fund its share of the 2nd Pipeline Project, and required that the remaining priority projects over \$1 million come back to the CVWD Board for consideration one by one. As a result, the other South Coast Member Units also reduced their funding approvals to the 2nd Pipeline Project only, leaving all other capital improvement work to be funded through the normal COMB budgeting process.

In addition, the 8,000 feet of the SCC that runs through the Sheffield Tunnel needs to be replaced, and how to do that has not yet been determined. It will be expensive and difficult, and will require challenging planning efforts to minimize water shut downs. There are still two reaches of the SCC that have not yet been inspected or analyzed to determine what additional repair or replacement projects will be needed for those sections of the SCC system. AECOM has just begun a third reliability study on the reach between the Ortega Control Station to Carpinteria Reservoir, which should be completed by Spring 2010. The final reliability study has not yet been scheduled.

In short, yes, COMB does have a capital improvement plan to inspect, analyze, repair and/or replace portions of the existing SCC structures other than what is called for as part of the 2nd Pipeline Project. The 2nd Pipeline Project and the rest of the initial priority projects will not restore the SCC facilities to its original condition. COMB, from now on, will need an ongoing capital improvement program, just as all the Member Units do. The first \$26 million of a multi-phased program has been developed. Future phases of the program will be developed as additional reliability studies are completed and the special studies (already identified) are conduced. The total overall projected costs cannot be identified until that time.

If the COMB Board decides to continue its Capital Improvement Program, there is no way to avoid increasing the COMB budget unless funding can be provided by long-term financing. COMB staff applied for federal and state stimulus money for the CIP Program, but our applications were unsuccessful. So as additional capital improvement projects are approved by COMB, and ratified by the Member Units if a project is over \$1 million, the COMB budget will increase.

What portions of the Second Barrel Project will be owned by the Bureau and which portions by COMB upon completion? For reference, only the cover structure on the Ortega Reservoir is owned by the Montecito and Carpinteria Valley Water Districts.

Reclamation will own the interties connecting the existing pipeline to the new pipeline, modifications to Corona del Mar Water Treatment Plant for connections only, and the new south portal structure. COMB will own the new section of pipeline. This is acceptable to Reclamation, and a written acceptance will be provided by them at the end of the project.

Staffing

It has been several months since COMB's only staff engineer resigned. Is recruitment underway for an in-house engineer for COMB? If not, why not?

As I discussed with you and the other Cachuma Managers in November, COMB's staffing structure needed to be evaluated and reorganized prior to hiring a new staff engineer, particularly with regard to supervisory and project management duties. In addition, the COMB bond process has taken an inordinate amount of my time and that of my Administrative Manager. Proposed revisions to the current staffing organization were discussed with the COMB Operating Committee at the November meeting, and I informed the Committee at that time that we were writing a new job description for Engineer, and would be recruiting for that position as soon as possible. Recruitment will begin in early January 2010.

Project costs

What detailed analysis exists to support the statement that re-bidding the Project may add another \$1 million dollars of cost? Was this a rhetorical number? If not, what was it based on?

There is no detailed analysis to support the opinion that rebidding the 2nd Pipeline Project will result in an increase of \$1 million over the original bids. It was based on the experienced engineering and seasoned construction management judgment of COMB's consultant engineer. It was also based on the range of bid amounts received, which averaged about \$9 million and ranged between \$11 million and \$8 million. This opinion was also shared by other General Managers and Board members, however others were of the opinion that the bids may come in lower than the original bids. Let's hope for the latter.

I'm glad you found that helpful.

To be responsive to that continuing need, at the December 2, 2009 Operating Committee meeting, I informed the Committee that this year we planned to prepare a 2-year budget for the first time, and that COMB staff would be presenting the preliminary budgets for FY 2010-11 and FY 2011-12 at the January 13, 2009 meeting for your review and discussion. Given that there may not be sufficient time for a full budget discussion in addition to the other items on the agenda, I'm happy to schedule a special Operating Committee meeting for that purpose. I would like to discuss proposed budget changes to the current FY 2009-10 Budget at that meeting as well.

I fully acknowledge the financial burden placed on all the Member Units by the State's economic situation, and the need to keep COMB costs as low as possible. But I also remain committed to the capital improvements needed for the Cachuma Project conveyance facilities in order to continue reliably delivering water to CVWD. I look forward to working with you to achieve both goals.

Charles -

Janet is working on a FY 09-10 budget reconciliation due to all the funding changes associated with the 2nd barrel project, but she has not completed it yet. There are several things I need to consider after that reconciliation is completed. The total COMB budget of \$3,365,727 was approved by the COMB Board, which included a \$1.1M debt repayment line item in the Special Projects section of the budget. Janet has made quarterly assessments on the entire budget. The debt repayment line item was not a separate special assessment. Now that the "2009 Project" to be financed is just the 2nd barrel project, that line item will be reduced, effectively freeing up some budgeted money that the COMB Board may choose to reallocate to other COMB O&M or capital improvement work, or to one or more of the studies that COMB has committed to doing recently (such as the Cost Benefit Analysis, or the Peak Demand Management Study). That calculation can't really be made until after the new bids are in to see what the 2nd pipeline project is actually going to cost and the total bond amount is known.

As I explained in an email to you last summer, when you suggested withholding a portion of CVWD's first quarter assessment, the absence (or reduction) of a bond issue does not preclude COMB from continuing improvements or repairs to the SCC delivery system. If the whole bond issue died, that \$1.1 million would be reallocated to other COMB CIP work. The assessments would not be refunded. With a reduction in the total debt repayment amount, my recommendation to the COMB Board will likely be to reallocate any freed up budgeted money to other COMB O&M or capital improvement work. In that event, the total COMB budget would not be reduced, nor would CVWD or any of the other Member Unit assessments be refunded.

Another funding consideration that you have brought up (or maybe it was Tom) is for CVWD to pay its 12.2% share of the O&M cost component for repair to the existing pipeline, currently included in the total cost for the 2nd barrel project. You indicated that your Board would very likely be willing to pay its normal share of those costs. I've asked Glen Hille to break out an estimate of those costs to get a more accurate total rather than just pull line items off of the low bid. The portion of your COMB assessment originally earmarked for debt repayment could be applied to CVWD's share of those costs if your Board agrees to do so, which would be \$134,200 for the entire fiscal year. This is fairly close to your estimate of about \$120,000 if the existing pipeline O&M were about \$1 million.

Once the COMB bond and associated agreements are finally approved, and Janet completes her reconciliation of the FY 09-10 budget, I will develop a preliminary recommendation for any proposed budget adjustments to the FY 09-10 budget for discussion at the COMB Ops Com meeting on Feb 3. A Board recommendation can then be developed for the Feb 22 COMB Board meeting. Therefore, until the COMB Board decides on any adjustments to this year's budget, I feel it would be premature to refund any of CVWD's assessments. We can discuss this in more detail at the Feb 3rd Ops Com meeting most of which will be dedicated to COMB budget considerations.

Charles -

Janet received a call from Norma Rosales, CVWD's Business Manager, regarding the payment of COMB's 1st Quarter FY 09-10 Budget assessment that was recently received by each of the member units. Norma said because the CVWD Board had not approved the COMB bond issuance, that the District would pay only the portion of the assessment that did not include the bond repayment.

This is not acceptable from COMB's perspective, and is counter to CVWD's contractual obligation under the COMB Joint Exercise of Powers Agreement, Article 4.2, amended in 2003. On June 22, 2009, the COMB Board of Directors unanimously approved the final budget for FY 2009-2010 for a total of \$3,365,727. There was no line item approval subject to an activity or obligation being implemented or completed; the entire budget was approved. Pursuant to the JPA, each of the COMB Member Units is obligated to pay COMB's costs, and those costs may be assessed in a manner approved by the COMB Board. COMB assesses the Member Units quarterly based on the total approved budget, unless the Board expressly indicates that an activity should not be assessed in advance of its implementation. That was not the case in approving the FY 2009-10 Budget.

The COMB budget, as has historically been the case, includes three basic sections: Operation & Maintenance, General & Administrative, and Special Projects, the latter of which specifies costs affiliated with larger capital maintenance or improvement projects primarily pertaining to the South Coast Conduit and appurtenant facilities, although costs associated with work at Bradbury Dam have also been included in this section in the past. In the FY 2009-10 Final Budget, Janet added a fourth section entitled Debt Service anticipating approval of the COMB 2009 bond issuance. That section was not segregated from the rest of the budget for a later approval. It was approved as part of the entire budget.

Neither COMB nor any of the Member Units have taken action on the proposed COMB bond, but those Board actions are separate from and unrelated to paying quarterly assessments for the approved COMB budget. The absence of a bond issuance will not preclude COMB from continuing capital improvement work to the Cachuma Project water delivery system on the South Coast. If the bond measure is not unanimously approved by COMB and ratified by all Member Units, the COMB FY 2009-10 Budget will not be reduced by the \$1,100,000 currently allocated for annual debt service on the bond. Rather, that budgeted money will be reallocated to other Special Projects of the Board's choosing so that COMB can continue to carry out vital, long-term capital improvements as it has done for many years in the past. This was made very clear in both the bond issuance presentations and the COMB FY 2009-10 Budget presentation.

Therefore, I would appreciate payment of the full amount of CVWD's 1st Quarter Assessment in the amount of \$102,144.30 by Friday, August 21, 2009.

RECOMMENDATION:

That the Board allocate the use of FY 2008-09 unexpended funds for the Mission Creek Pipeline and Fish Passage Project

DISCUSSION:

The unexpended fund amount as shown by the auditor from the FY 08-09 audited financial statements is \$735,795. These unexpended funds were generated primarily from the special projects area of the budget in which projects were not completed during the FY08-09 fiscal year. The attached table outlines the breakdown of unexpended funds categorized between the Operation and Maintenance, General and Administrative, Special Projects and IRWMP sections of the budget. The table reflects the allocated percentages for the unexpended funds in each category according to the member units' contribution of the budget revenues.

In January 2009, the COMB board approved the use of unexpended funds in the amount of \$100,000 from FY 07-08 for the SCC South Reach Reliability Study, which is underway and is scheduled to be completed by March 2010.

In June 2009, the Board approved a budget adjustment for \$375,000 in order to accommodate expenses incurred for damages at the Lauro Reservoir affiliated with the Jesusita Fire. Since that time, we have submitted a claim in the amount of \$421,062 to ACWA/JPIA for reimbursement on damages sustained from the fire. In October 2009, we received a check from ACWA/JPIA in the amount of \$136,898 for some of the items presented in the claim. The carrier is currently evaluating the remaining expenses submitted for eligibility. For purposes of reconciling the unexpended funds from FY 08-09, the table reflects the insurance reimbursement as well as the net previously approved unexpended funds. It is anticipated that there will be about \$680,000 in unexpended funds after receiving full reimbursement from ACWA/JPIA for the Jesusita Fire activities.

The use of these funds was discussed with the Cachuma General Managers at the December 2, 2009 Operating Committee meeting. Because the Mission Creek Pipeline and Fish Passage Project is the next highest priority CIP project that needs to be done, your General Manager and the Committee recommend that the unexpended funds be designated for the Mission Creek

DISCUSSION:

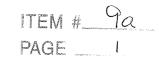
The project started on August 25, 2009 and was completed on November 18, 2009. All instream work was completed on November 3, 2009. The objectives of the project were to improve fish passage by back-watering a passage impediment, increase available habitat from one pool to five pools, stabilize the stream banks, re-vegetate with native plants, and install a temporary irrigation system until all plants are self-sustainable. Since completion, the project has been inspected by the project engineer Edward Wallace (Northwest Hydraulics Consultants), California Department of Fish and Game (CDFG) grant manager Mary Larson and fish passage engineer Marcin Whitman (appointed oversight engineer for the National Marine Fisheries Service, NMFS), vegetation restoration coordinator Meredith Hardy (California Conservation Corps, CCC), project manager Tim Robinson (COMB), landowners Cathy and Kirk Romain, and the Manager Engineering Oversight Committee (MEOC). All components of the project were successfully completed as designed.

A final project report with As-Built drawings has been sent to all permitting regulatory agencies, NMFS, Reclamation, and the stakeholders. No further tasks remain beyond: 1) finalizing reimbursements from the two granting agencies; 2) establishing a maintenance and ownership agreement with the landowner; and 3) completing the annual performance monitoring and reporting requirements each fall for the next five years.

Schock Contracting Corporation did a commendable job. They stayed within the construction schedule, cleaned up the site to the landowner's and project engineer's satisfaction, and kept construction costs within 8.2% of the contracted amount. All stakeholders, specifically the landowners, CDFG representatives, and CCC vegetation restoration coordinator, were very pleased with the outcome of the project which was a testament to the positive working relationship established among all parties involved.

Completed:

- Concrete and rock work to shore-up the low-flow crossing and install a curb on the downstream side to focus the flow to the center.
- Six weirs to backwater the low flow crossing and the associated rock-slope-protection.
- Complete re-vegetation of the construction area.



- Rock-slope-projection above the low-flow crossing to replace gabion baskets.
- Approach roads on both sides of the crossing.
- Rock slope projection on the north back in association with the approach road.
- Small drainage swales, one on the north and one on the south banks.
- Removal of the dewatering system and silt fencing.
- Staging area cleanup.
- Installation of the irrigation system

Change orders:

A total of four change orders were submitted and approved by the COMB Board. All except Change Order #2 were completed for less than the authorized amount.

Change Order #1: Additional rock-slope-protection to shore-up the north approach road

(\$15,120 - Board approved on 9/28/09; actual cost - \$12,600).

Change Order #2: Additional concrete for the southern wing slab on the low flow crossing

(\$12,523 - Board approved on 10/26/09; actual cost - \$12,523).

Change Order #3: Unexpected buried bridge piling removal (\$9,315 - Board approved on

10/26/09; actual cost - \$6,796).

Change Order #4: Additional concrete for the north approach road coming to the crossing

(\$5,000 - Board approved on 10/26/09; actual cost - \$4,901).

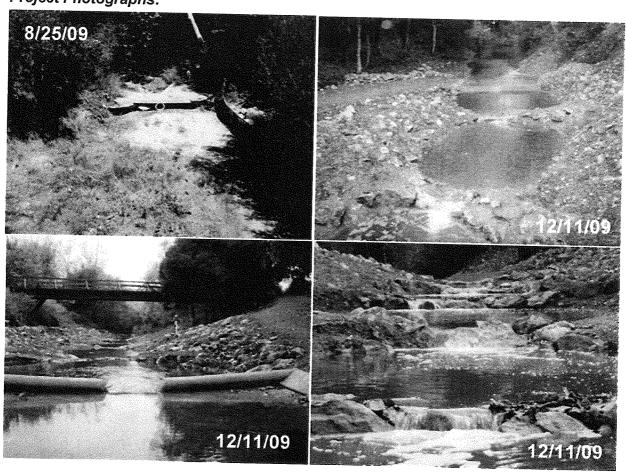


Figure 1: Projects photos from before the project started and after the completion of the project during the December 11, 2009 storm. Fish passage for juvenile and adult southern steelhead is now possible at all flows.

Dear Mr. Williams,

There is a consensus that water supply reliability from Cachuma and the State Water Project needs to be improved. As you are well aware, water delivered through the Cachuma Project conveyance facilities is a critical water source for the people of Santa Barbara, Goleta, Carpinteria, and Montecito. In the event of a natural disaster or a dramatic increase in water demand, the current water infrastructure may not be able to supply the needs of the South Coast residents.

While I understand that some local funding issues have arisen and some of those who will benefit from the project have opted not to pay for the project, it is critical that this project move forward. One of the most important pieces of the financing puzzle on this project is \$3.2 million dollars in Prop 50 grant money from the State Water Resources Control Board. I am concerned that the local political uncertainty could jeopardize this funding source if the project is delayed.

From both a water supply and economic perspective, the benefits to the communities of Santa Barbara County from this project are substantial. Continued delays should be avoided and I would encourage you to take the necessary steps to get this project moving right away.
